Article V, Section 3 of the Maryland Constitution Regarding the Attorney General's Authority.

Honored members Today, Thursday, August 8, 2012, I come to support Delegate Don Dwyer previously introduced impeachment charges of 2010 against our Attorney General of the State of Maryland, Douglas F. Gansler. <http://www.daggerpress.com/2010/03/31/del-impallaria-impeachment-proceedings-against-attorney-general-doug-gansler/> Delegate Dwyer, before the entire body of the House of Delegates, read out clearly and concisely the authority of the body to bring impeachment charges against a constitutionally elected Officer of the State and also clearly laid out the reasons why Mr. Gansler should be impeached by the House of Delegates. To be absolutely clear about what impeachment means, it is similar to a Grand Jury looking at the facts of a case and voting that the case should be sent to trial.
